There is currently a period of public consultation on alternative proposals for the reorganisation of local government in Surrey proposed by Central Government that will replace Surrey County Council and 11 District and Borough Councils with either 2 or 3 unitary authorities. The role and status of Farnham Town Council (FTC) will remain unchanged although a new Neighbourhood Area Committee consisting of elected representatives of FTC and the new unitary and other local community organisations and involved stakeholders (e.g. Police and NHS) will be formed to establish a working relationship between Town / Parish Councils and the new unitary for management and administration of local government. There will be elections to create shadow authorities in May 2026 with the new unitary authorities going live in May 2027 when it is also likely that there will be elections for an all Surrey Mayor.

At a meeting of Farnham Town Council's Full Council held on 19 June it was agreed to formally support the 3 unitary proposal in which Waverley would be joined with Guildford, Woking and Surrey Heath. Such a unitary would be able to build on the joint management teams that have been developing between Waverley and Guildford

I would encourage you to participate in this public consultation. When responding It is important that you respond to all 3 parts saying "no" to the proposal that you would not wish to see implemented as well as "yes" to the proposal that you would wish to see implemented.

Like FTC I personally support the 3 unitary proposal as the "best available option". I would have preferred to have started with a clean sheet of paper to allow the feasibility of creating a unitary in which Farnham would have been included in a Blackwater Valley unitary authority but this has not been possible since Central Government has insisted that the new unitary authorities should be made up of existing local authorities within existing County Council boundaries. In my personal opinion this is a wasted opportunity to revise the shape of local government and do the job properly.
