<p>Planning Matters:</p>	
<p>Footpath: SCC have approved the new public footpath from UCA across the bottom of the field to the existing footpath leading from Crondall Lane up the side of the field, with the route tracking along the back fences of Beavers Close properties. SCC said that after the path has been approved it will be measured in detail. The path at the UCA end is exactly what we want but it raises issues. It has to be advertised once the final route has been decided and people can object. Taylor Wimpey (TW) have said they will propose a diversion which will probably go down the road. NWFRA will not take a position on this issue until more details are available.</p>
